 - (ii) The Item will not be supplied in any way, directly or indirectly via third party organizations to an entity/person in or from North Korea, Syria, Russia, Iran, Sudan or the Crimea Region of Ukraine.
 - (iii) We will not make any unauthorized export, re-export or transfer to any entity or person that is on any export control restricted list, including any entity that is, to the best of our knowledge owned 50% or more, directly or indirectly, by such restricted entity or person.
 - (iv) We will only re-export or transfer to a third party on condition that the third party accepts the commitments listed in this declaration as binding for itself and on condition that the third party is known to be trustworthy and reliable in the observance of such commitments.
- We further certify that the Item will not be used or likely to be used, wholly or in part for or in connection with any of the following:
 - (i) the design, development, production, handling, operation, maintenance, storage, detection, identification or dissemination of any nuclear, chemical or biological weapon;
 - (ii) the design, development, production, maintenance or storage of systems that are capable of delivering such weapons (e.g. missiles, rockets or unmanned air vehicle systems); or
 - (iii) threats to public security and/or human rights violation.
- We certify that the Item will only be used for civil end-uses and will not be supplied to a "military end-user being the national armed services (army, navy, marine, air force, or coast guard), as well as the national guard and national police, government intelligence or reconnaissance organizations, or any person or entity whose actions or functions are intended to support a 'military end-use' (*).

Appendix: Definitions

- UBO and Pseudo-UBO:

Qualification UBO: Every legal entity does have at least one ultimate beneficiary owner (ubo); a natural person who ultimately owns or controls the legal entity. Not every single ubo qualifies as an Ultimate Beneficiary Owner (UBO).

In case a natural person: owns more than a 25% interest in a company or owns more than 25% of the voting rights in a company, or is the beneficiary of more than 25% of the assets of the company, he or she qualifies as a UBO. It is important to state that these points are important indicators, but do not make up an exhaustive list. It is therefore possible to qualify as a UBO without meeting the above-mentioned indicators (e.g.: a person with an interest of 10% whose family member has an interest of 20% and/or is a managing director may also qualify as a UBO (or both may qualify as a UBO).

Qualification Pseudo-UBO: If, after having exhausted all possible means and provided that there are no grounds for suspecting there to be a UBO, no person holding direct or indirect ownership can be identified, or if there is any doubt that the person identified is the beneficial owner, a natural person who holds the position of senior managing official of the client will be deemed to be the pseudo-UBO. It is advisable to appoint a managing director as the pseudo-UBO given the registration in the Trade Register.

- Military end-use will mean:

- (a) incorporation into military items listed in the military list. For latest update see www.wassenaar.org
- (b) use of production, test or analytical equipment and components therefor, for the development, production or maintenance of military items listed in the above-mentioned list;
- (c) use of any unfinished products in a plant for the production of military items listed in the above-mentioned list.
